
Rockabill Consulting & Development Promotes Sean McNamara to Vice President

The aforementioned appointments top off a busy year for Rockabill. In November 2021, the firm broke ground on a 94-unit affordable housing development for seniors in Bushwick, Brooklyn. Working in partnership with Southside United HDFC, the project—Rheingold Senior Residences—aims to set a new

standard for deeply affordable housing for aging New Yorkers while achieving passive house standards to help mitigate the health impacts of a warming climate.

Also last year, Rockabill marked the completion and opening of Vincent's Village, a \$42 million affordable and supportive housing development in the village of Nanuet in Rockland County. Supported with financing from New York State Homes and Community Renewal (HCR), the development has 93 affordable homes with on-site health and wellness services for adults age 55 and older.
